**B- Requirements to receive a partial scholarship:**

- 1) Fill out the application and send it to the REM Committee Chair on or before the deadline of **November 22nd, 2010**. Scholarship announcement will be made on or before **December 21st, 2010**.
- 2) If awarded, do attend the conference. Please let us know if you did not attend.
- 3) Within 15 days, use region's **reimbursement form** to claim expenses up to the amount of scholarship. Send the original and a copy of reimbursement form and receipts to the Chair of the SW Regional REM committee. The Chair will then attach original receipts with signed reimbursement form and send to the Regional Director (Bill Carpenter) at the address below. A check will not be issued until the Regional Director receives both the original receipts and signed authorization from the Chair of the SW Regional REM Committee.
- 4) EMAIL your written reflection **within 30 days of returning** from the REM Invitational. This may be shared with the Regional Membership via the Region's webpage and newsletter.
